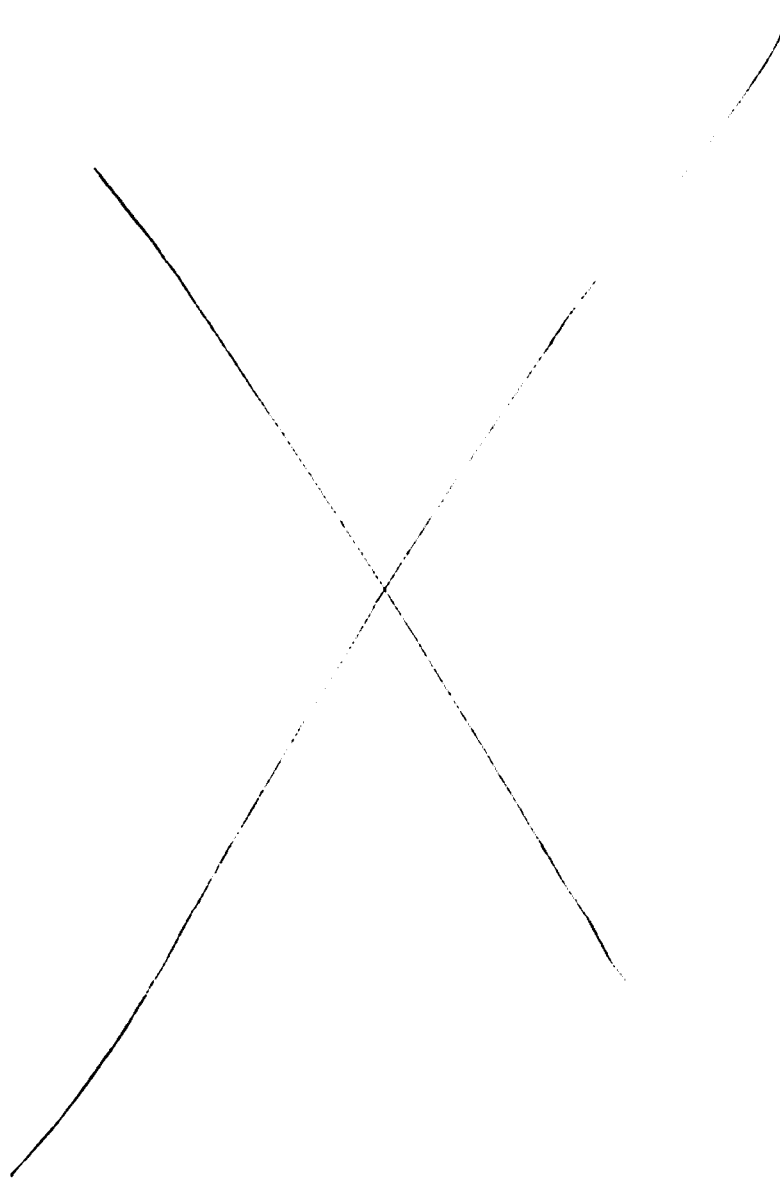

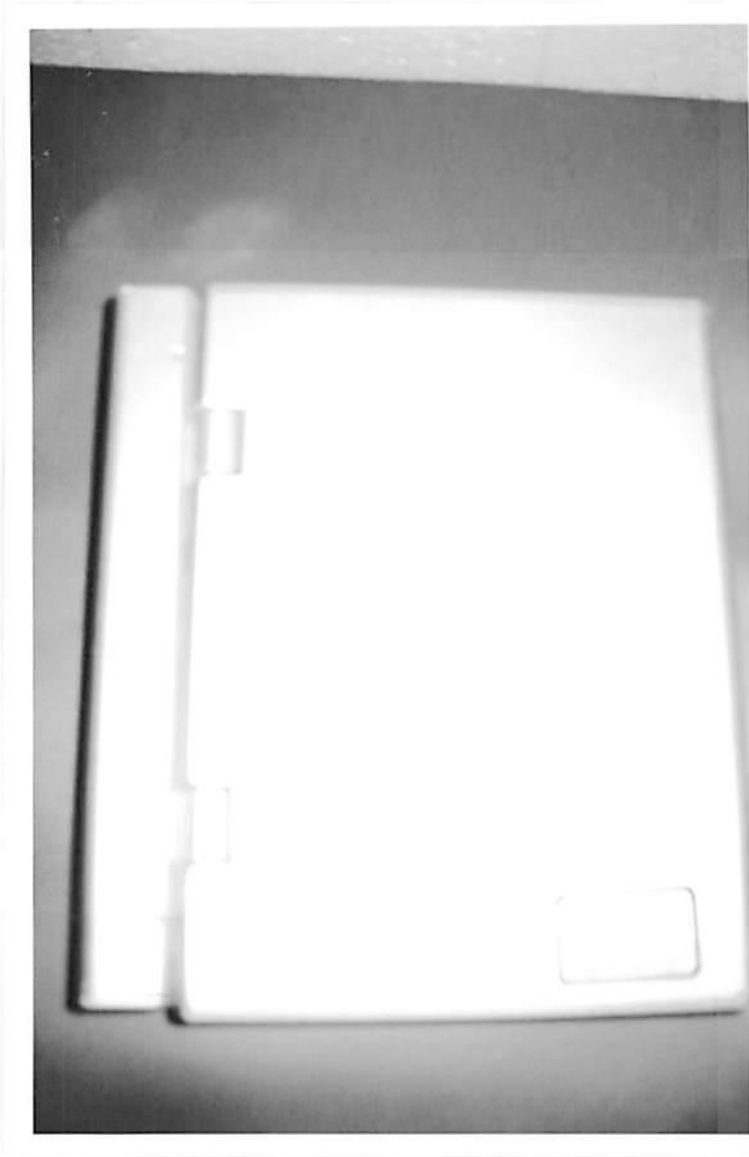

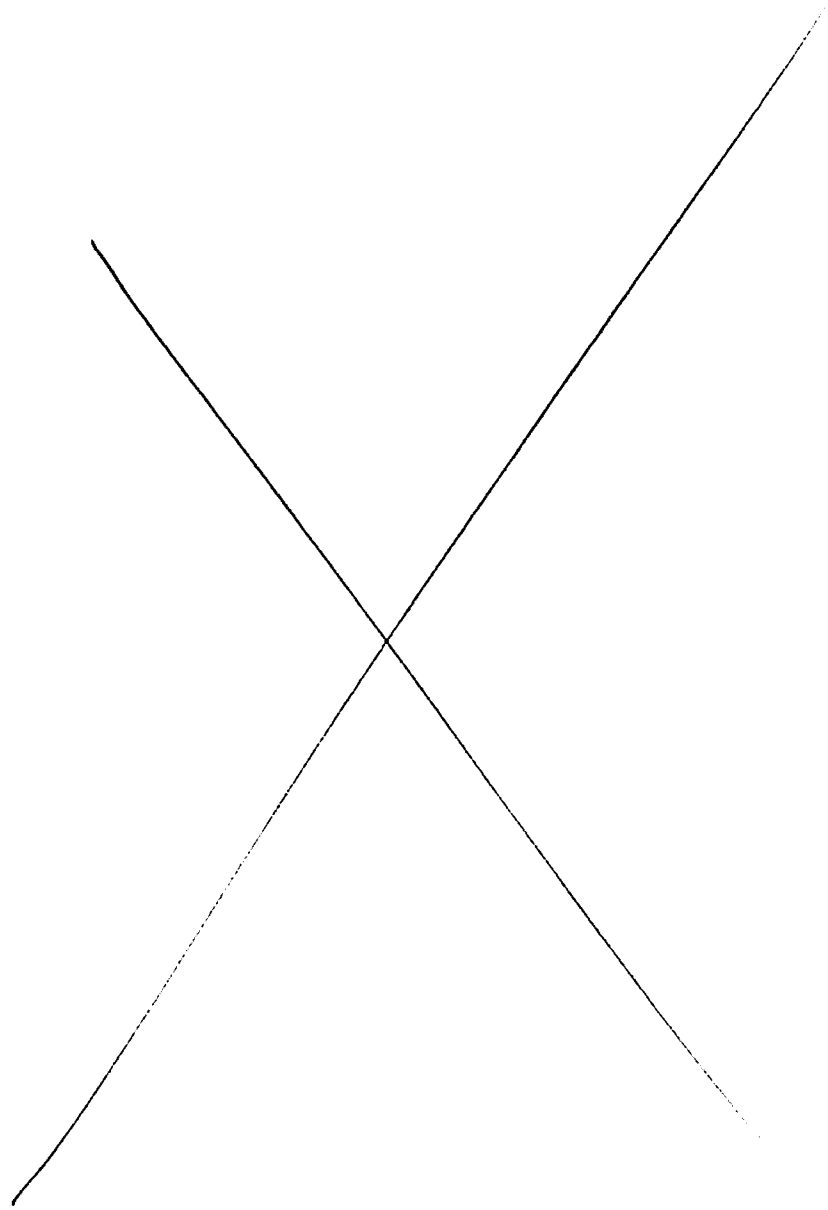

DIAGRAM OF FEMALE

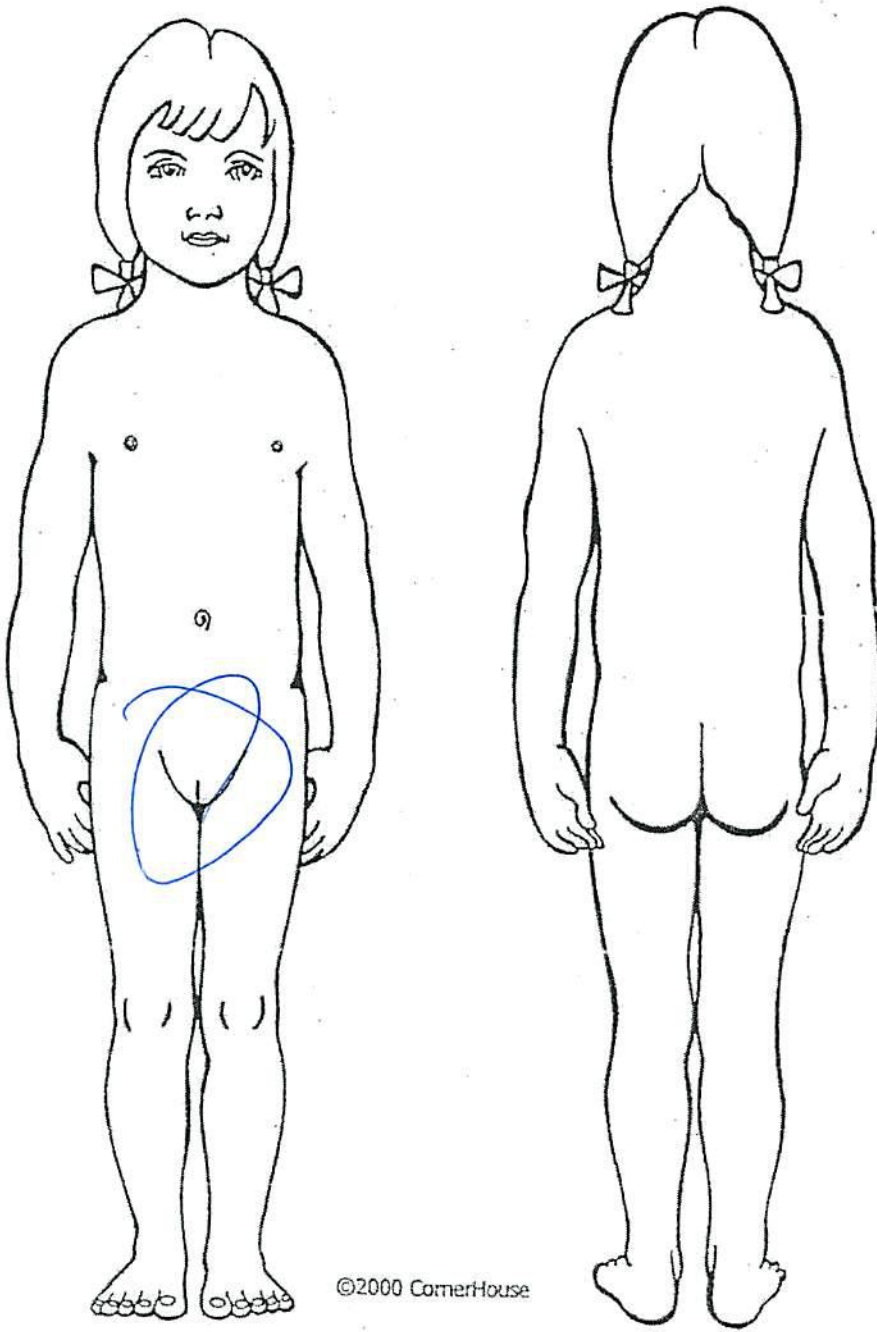

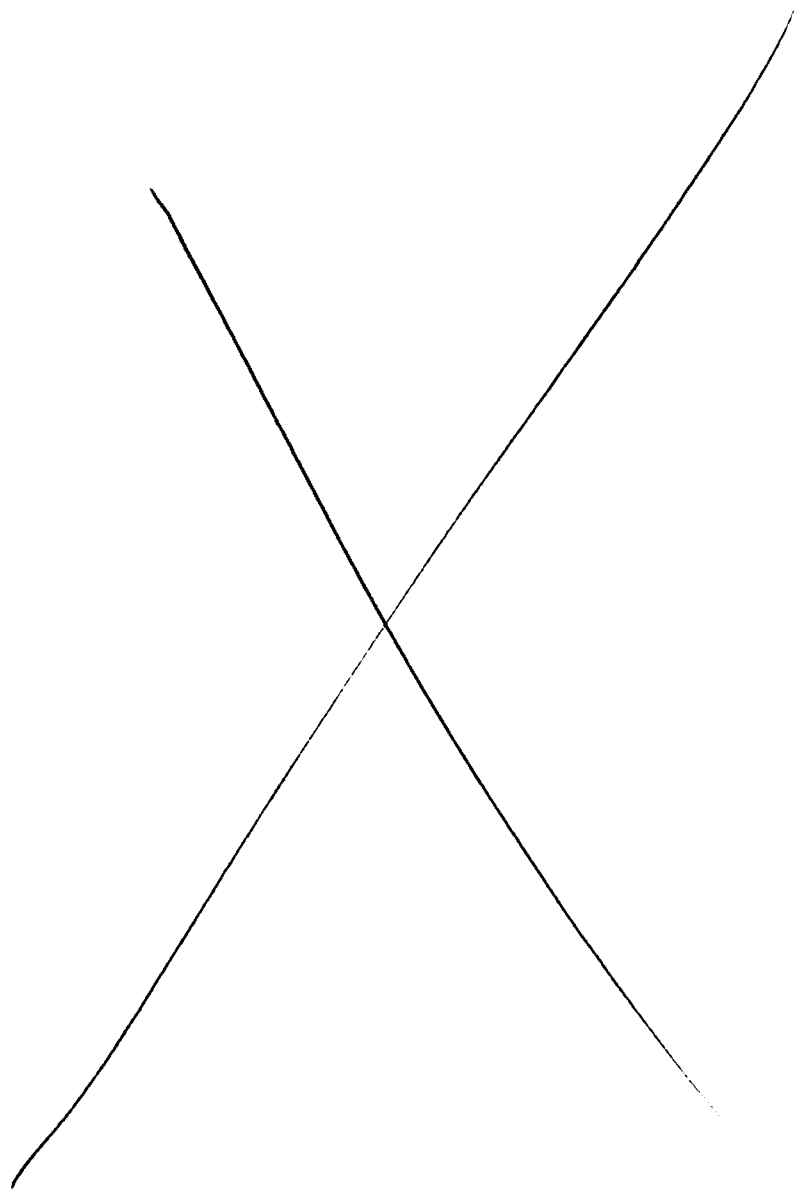

DIAGRAM OF MALE

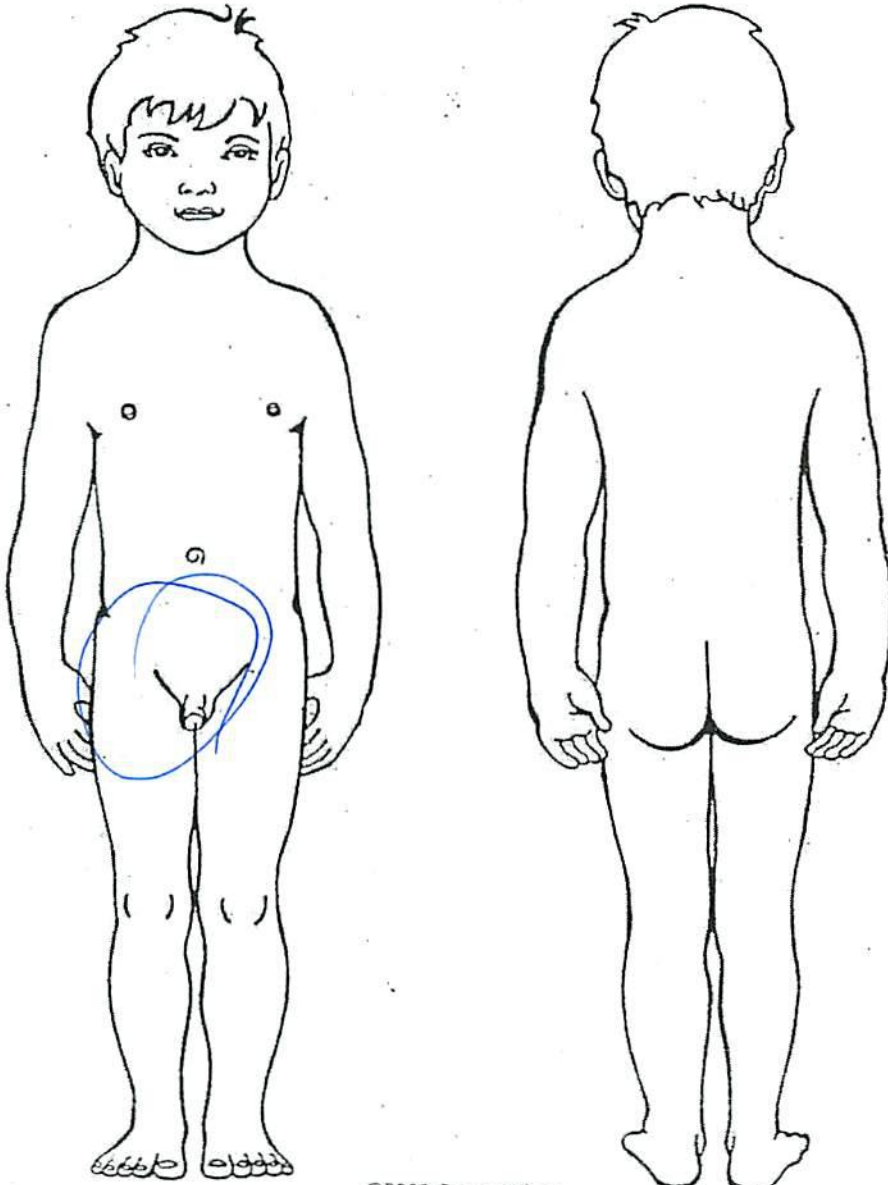
