1 DONNA BLACK: This room, look over here. This is my office. I've  
2 got butterfly curtains. Do you like butterflies?

3 ANNIE YOUNG: Uh huh.

4 DONNA BLACK: And this is what we call our interview room. This  
5 is where we bring kids when we want to talk to them. We talk to a lot of kids  
6 back here. You see the hand prints on the wall?

7 ANNIE YOUNG: Uh huh.

8 DONNA BLACK: Those hand prints are all from kids who we've  
9 talked to in this room. So, this is your chair and this is where I'm gonna sit.  
10 Okay? And you don't have school today or did you just have to get out of  
11 school?

12 ANNIE YOUNG: I had to get out of school.

13 DONNA BLACK: You had to get out of school. Where do you go to  
14 school at?

15 ANNIE YOUNG: North Harrison.

16 DONNA BLACK: Do you really? What grade are you in?

17 ANNIE YOUNG: First.

18 DONNA BLACK: First grade. Let's see, who are the teachers for  
19 first grade. Miss Hampton? She's nice, isn't she? My daughter had her when  
20 she was in the second grade, when Mrs. Hampton used to teach the second  
21 grade. So she's really nice. So you just took off part of the day today, kind of  
22 take a break? Is that fun?

23 ANNIE YOUNG: Uh huh.

24 DONNA BLACK: Uh huh?

25

1 ANNIE YOUNG: Actually I didn't go to school.

2 DONNA BLACK: You didn't go at all?

3 ANNIE YOUNG: Huh uh.

4 DONNA BLACK: Are you gonna go this afternoon?

5 ANNIE YOUNG: ...interview.

6 DONNA BLACK: For an interview? You gonna go to school this  
7 afternoon maybe?

8 ANNIE YOUNG: Huh uh.

9 DONNA BLACK: No, just gonna take off?

10 ANNIE YOUNG: Uh huh.

11 DONNA BLACK: Well, it's Friday, isn't it? Almost the week-end.

12 So I'm gonna tell you some things about our room. Can you see this thing right  
13 back here?

14 ANNIE YOUNG: Yeah.

15 DONNA BLACK: And this thing over here?

16 ANNIE YOUNG: They're cameras.

17 DONNA BLACK: They're cameras, yeah, and they're taking our  
18 picture. Okay? That's so that we can record what you're telling us and that also  
19 allows some other people to hear us we're talking, okay? That way if I forget to  
20 ask you something, they can let me know what I need to remember to ask.

21 Okay? There's also this thing hanging right here. It kind of looks like a cotton  
22 ball hanging from the sky.

23 ANNIE YOUNG: What is it?

24 DONNA BLACK: That's a microphone. That way they can hear us,  
25 okay? ...from where they're at. This thing right here...

1 ANNIE YOUNG: Are you gonna make me put my hand on the wall?

2 DONNA BLACK: I'm not gonna make you, honey. If you want to  
3 put your hand print on the wall, you'll be able to.

4 ANNIE YOUNG: I do.

5 DONNA BLACK: You do? Okay, well, when we're finished, we'll  
6 work on that, okay? All right, so I'm gonna use this. This is what I call a bug. It  
7 doesn't really look like a bug. But it let's other people talk to me and I can hear  
8 what they're saying. Okay? All right. And I also wanted to tell you that while  
9 we're in this room talking, we can talk about anything we need to, okay? It's a  
10 safe room. We're not gonna be in trouble for anything we talk about. You can  
11 use any words you need to use. Okay? Uhm, you're gonna find that sometimes  
12 forget that I've already asked you a question and I might ask it again. Okay?  
13 You can just, you can remind me that I've asked you. I might have just forgot  
14 what you told me. Okay? Or if I ask you something and you just don't know an  
15 answer, you can say, "I just don't know. I don't know." Okay? So it's all right to  
16 say that you don't know. Do you have any questions for me?

17 ANNIE YOUNG: No.

18 DONNA BLACK: All right. Well, I know that your name is Annie.

19 ANNIE YOUNG: Well, actually yeah, but what is that for?

20 DONNA BLACK: That's a paper because we're gonna draw on it.  
21 Okay? I'm gonna write, first of all I'm gonna write my name here. My name's  
22 Donna. So if you need to ask me a question, you'll know that. And your name is  
23 Annie, right?

24 ANNIE YOUNG: Yeah.

25 DONNA BLACK: And is it...

1 ANNIE YOUNG: A-n-n-l-e.

2 DONNA BLACK: A-n-n-l-e. How old are you, Annie?

3 ANNIE YOUNG: Seven.

4 DONNA BLACK: Seven. When's your birthday?

5 ANNIE YOUNG: June 21st.

6 DONNA BLACK: So you're almost eight. Right? And now what's  
7 today's date? Do you know? April...

8 ANNIE YOUNG: April....

9 DONNA BLACK: Eighteenth? Eighteenth, okay. One of the things  
10 that I do when I talk to kids is I like to draw a picture of their face. Okay? Can  
11 you help me to that? Okay. You've got a circle, and it looks like we've got some  
12 eyes.

13 ANNIE YOUNG: I've got brown...

14 DONNA BLACK: You've got brown eyes. You sure do. And you've  
15 got what else?

16 ANNIE YOUNG: Teeth.

17 DONNA BLACK: Teeth. So you want to put a smile on your face?  
18 And you want some teeth in there? What are we missing now?

19 ANNIE YOUNG: Hair.

20 DONNA BLACK: Hair. You've got long hair. What color is it?

21 ANNIE YOUNG: Brown.

22 DONNA BLACK: Brown. Down here. Okay. Did I miss anything  
23 on your face? What?

24 ANNIE YOUNG: ...eyebrows.

25 DONNA BLACK: Eyebrows, okay. What else?

1 ANNIE YOUNG: Missing a nose.

2 DONNA BLACK: The nose. I was gonna say, that's a pretty  
3 important thing there that we're missing. Uh, something like that maybe.

4 ANNIE YOUNG: (inaudible)..., ears.

5 DONNA BLACK: Your ears.

6 ANNIE YOUNG: With earrings.

7 DONNA BLACK: With earrings in them, okay. How does that look?

8 ANNIE YOUNG: Good.

9 DONNA BLACK: Good. All right. It looks sort of like you. Okay.

10 Uhm, how about, let's talk about where you live. Do you live in a house or a  
11 trailer...

12 ANNIE YOUNG: Trailer.

13 DONNA BLACK: A trailer. Okay, so we'll try to draw it a little bit like  
14 a trailer.

15 ANNIE YOUNG: I know how to draw a trailer.

16 DONNA BLACK: You do? Do you know how to write?

17 ANNIE YOUNG: Uh huh.

18 DONNA BLACK: I'll have you write this one. Can you write down  
19 the names of everybody that lives in your house with you?

20 ANNIE YOUNG: Uhm...

21 DONNA BLACK: Where is your trailer? Do you know what your  
22 address is?

23 ANNIE YOUNG: No.

24 DONNA BLACK: No?

25 ANNIE YOUNG: I don't know the address. Tonya...

1 DONNA BLACK: Tonya. Is that your mom? Do you know how to  
2 spell it?

3 ANNIE YOUNG: Huh uh.

4 DONNA BLACK: Uhm, it might be T-o-n...

5 ANNIE YOUNG: ...y...

6 DONNA BLACK: ...y-a. Does that sound right?

7 ANNIE YOUNG: Yeah, kind of.

8 DONNA BLACK: Okay, do you want to put an "A" at the end of it?  
9 Tonya. Who else lives there?

10 ANNIE YOUNG: Eddie.

11 DONNA BLACK: Eddie? And who is Eddie?

12 ANNIE YOUNG: He's not really my dad, but he's my mom's  
13 boyfriend.

14 DONNA BLACK: Oh.

15 ANNIE YOUNG: My dad is (inaudible).

16 DONNA BLACK: He is?

17 ANNIE YOUNG: (inaudible)...

18 DONNA BLACK: Oh, his drivers license is suspended. Okay. Do  
19 you know how to spell "Eddie"?

20 ANNIE YOUNG: Huh uh.

21 DONNA BLACK: No? E-d, another "D", and probably a "Y". Eddy.

22 ANNIE YOUNG: My brother don't live (inaudible).

23 DONNA BLACK: He doesn't live there though?

24 ANNIE YOUNG: Huh uh.

25 DONNA BLACK: Well, let's put him down here. What's your

1 brother's name?

2 ANNIE YOUNG: Allen.

3 DONNA BLACK: Allen? How old is he?

4 ANNIE YOUNG: Twelve.

5 DONNA BLACK: Twelve? What grade is Allen in?

6 ANNIE YOUNG: I don't know...

7 DONNA BLACK: Sixth? Fifth or sixth grade? Okay, who else lives  
8 here?

9 ANNIE YOUNG: Our dog.

10 DONNA BLACK: Your dog? What's his name?

11 ANNIE YOUNG: Her. We're trying to keep her from having  
12 puppies, but we can't afford it.

13 DONNA BLACK: Yeah. Sometimes dogs have puppies. So we've  
14 got Daisy. D-a-l-s-y, maybe. And she's a dog.

15 ANNIE YOUNG: (inaudible).

16 DONNA BLACK: Okay.

17 ANNIE YOUNG: ...we have Sailor, our dog...

18 DONNA BLACK: You have a dog named Sailor?

19 ANNIE YOUNG: It's a big dog. He's a hunting dog.

20 DONNA BLACK: Is that right? Sailor, S-a-l-l-o-r. I see somebody  
21 you've forgotten that lives in that trailer. You have mom and Eddie and Allen and  
22 Daisy and Sailor. Who are we missing?

23 ANNIE YOUNG: That's all we have. Oh, me.

24 DONNA BLACK: Now, do you have more than two dogs? Or just  
25 the two?



1 ANNIE YOUNG: I have another one. And it's a she and her name  
2 s (inaudible).

3 DONNA BLACK: (inaudible)

4 ANNIE YOUNG: But most of us just call her (inaudible.)

5 DONNA BLACK: Okay, you want to write her down?

6 ANNIE YOUNG: (inaudible).

7 DONNA BLACK: So you have Mom and Eddy and Annie and Allen.

8 ANNIE YOUNG: And Sailor and Daisy (inaudible.)

9 DONNA BLACK: Okay, does anybody else live there?

10 ANNIE YOUNG: Well...

11 DONNA BLACK: Is that it? All right.

12 ANNIE YOUNG: (inaudible)

13 DONNA BLACK: Well, we might. Uh...

14 ANNIE YOUNG: I know what it looks like. While you're drawing  
15 that, maybe we can talk about something else. Is there, do you ever have any  
16 uh, do you ever stay anywhere else or does anybody ever babysit you?

17 ANNIE YOUNG: Well, I stayed, well, I stay at my friend Summer's  
18 house.

19 DONNA BLACK: Summer? Does Summer live close to you?

20 ANNIE YOUNG: Uh huh, she lives right beside me.

21 DONNA BLACK: Huh, okay. Okay, well, I'll tell you what. We have  
22 (inaudible), and this is uh, what I need, what I'm gonna ask you help me do here  
23 is to, I get to define some body parts. Okay? Do you know what that means?

24 ANNIE YOUNG: Uh huh.

25 DONNA BLACK: Tell me what things are called. Okay. And the

1 reason we do that is because sometimes that what you call a body part, I might  
2 call something else. So what do you call this piece on your face, right here, right  
3 here we talked about?

4 ANNIE YOUNG: Nose.

5 DONNA BLACK: A nose. Some people might call that a noggin.  
6 Have you ever heard it called a noggin?

7 ANNIE YOUNG: This is a noggin.

8 DONNA BLACK: That, see, okay. I call that a "head", but some  
9 people call that a "noggin". So we're gonna talk about that, okay? Uhm, the first  
10 thing I want you to do, Annie, is which one of these is the boy and which one's  
11 the girl?

12 ANNIE YOUNG: Boy, girl.

13 DONNA BLACK: Girl, okay. And which one is like you? Okay.  
14 Let's work on her first. Okay. You want to hold it up there while I tape it? What  
15 the trailer looks like..., you've got a lot of stairs going into it. All right.

16 ANNIE YOUNG: I like to draw.

17 DONNA BLACK: Do you really? Do you like art class? Who's your  
18 art teacher?

19 ANNIE YOUNG: Ms. Kramer.

20 DONNA BLACK: Ms. Kramer? And do you like to go to art class  
21 and draw? All right. So let's talk about, what's this right here? What do you call  
22 that right there?

23 ANNIE YOUNG: I call it hair.

24 DONNA BLACK: Hair, okay. What do you call that right there?

25 ANNIE YOUNG: Lips.

1 DONNA BLACK: Lips. And what do you call this right here?

2 ANNIE YOUNG: Arm.

3 DONNA BLACK: Arm. And what do you call this right here? Okay,  
4 there we go.

5 ANNIE YOUNG: Belly button.

6 DONNA BLACK: Belly button, okay. And this?

7 ANNIE YOUNG: My mom... (inaudible).

8 DONNA BLACK: Okay. And what about this right here?

9 ANNIE YOUNG: Toes.

10 DONNA BLACK: Toes. All right, how about back here?

11 ANNIE YOUNG: Back.

12 DONNA BLACK: Back. That's pretty easy, isn't it? And this?

13 ANNIE YOUNG: Butt.

14 DONNA BLACK: All right. And this right here?

15 ANNIE YOUNG: Leg.

16 DONNA BLACK: And leg. All right. All right, let's do the same  
17 thing with the little boy now. Okay, thank you. I appreciate that. Okay. All right.  
18 Well, let's do some different ones this time. What do you call this? We didn't talk  
19 about that on the girl.

20 ANNIE YOUNG: Eye, eye ball.

21 DONNA BLACK: An eyeball. Okay. And actually put one of those  
22 on you, didn't we? Right here?

23 ANNIE YOUNG: Yeah.

24 DONNA BLACK: Uhm, what about this?

25 ANNIE YOUNG: Noggin. I call it noggin.

1 DONNA BLACK: Okay. And what about this?

2 ANNIE YOUNG: We did that on the girl.

3 DONNA BLACK: We did.

4 ANNIE YOUNG: That's (inaudible).

5 DONNA BLACK: What is it?

6 ANNIE YOUNG: Well, me and my mommy (inaudible).

7 DONNA BLACK: Okay. What about these things right here?

8 ANNIE YOUNG: Fingers.

9 DONNA BLACK: Fingers. How many fingers have you got?

10 ANNIE YOUNG: Five.

11 DONNA BLACK: Five.

12 ANNIE YOUNG: Ten.

13 DONNA BLACK: Five on each hand, ten total? All right. How

about this?

14 ANNIE YOUNG: Weeny-bob.

15 DONNA BLACK: What is it?

16 ANNIE YOUNG: Weeny-bob.

17 DONNA BLACK: Weeny-bob? Okay. And what's this?

18 ANNIE YOUNG: Knee.

19 DONNA BLACK: Knee.

20 ANNIE YOUNG: I have another one.

21 DONNA BLACK: What?

22 ANNIE YOUNG: Me and my mom calls it bumps.

23 DONNA BLACK: A bump? Yeah, because it's like a bump, isn't it?

24 ANNIE YOUNG: Yeah.

25

1 DONNA BLACK: All right. What do you call this thing back here?

2 ANNIE YOUNG: Neck.

3 DONNA BLACK: And this again?

4 ANNIE YOUNG: Back.

5 DONNA BLACK: And this?

6 ANNIE YOUNG: Butt.

7 DONNA BLACK: Anything we missed?

8 ANNIE YOUNG: Uh huh.

9 DONNA BLACK: What did we miss?

10 ANNIE YOUNG: Ankle.

11 DONNA BLACK: His ankle, all right. Boy, you know all the body  
12 parts. Do you study that at school? Have you started studying body parts at  
13 school? All right. So Annie, can you tell me, or just can you place yours on this  
14 little girl's body or on a little girl's body or a little boy's body that other people  
15 shouldn't touch?

16 ANNIE YOUNG: Uh huh.

17 DONNA BLACK: Can you show me those parts? Okay, you want  
18 to circle them? Okay.

19 ANNIE YOUNG: (inaudible).

20 DONNA BLACK: Oh, okay. How can you get rid of germs?

21 ANNIE YOUNG: Put hand sanitizer on them.

22 DONNA BLACK: Put hand sanitizer on them? Or wash them really  
23 good.

24 ANNIE YOUNG: Or...(inaudible)

25 DONNA BLACK: Okay. So you tell you that you think on, on little

1 girls, other people shouldn't touch their lips?

2 ANNIE YOUNG: Or their mouth.

3 DONNA BLACK: Their mouth?

4 ANNIE YOUNG: Inside their mouth.

5 DONNA BLACK: And how come, how come they shouldn't touch  
6 inside of their mouth?

7 ANNIE YOUNG: They'll get a whole bunch of wet stuff on them and  
8 germs.

9 DONNA BLACK: They'll get germs on them. Okay, and how about  
10 their hands?

11 ANNIE YOUNG: They have germs on them too. (Inaudible)

12 DONNA BLACK: Okay, and you said they shouldn't touch little girls'  
13 pee-pee. Okay. And her butt. Okay. And then on the little boy you said people  
14 shouldn't touch his mouth, probably for different, or the same reasons. Okay.  
15 Or his, you call that a weeny-bob? Okay, or his butt. So, okay. And what are  
16 those called on a boy?

17 ANNIE YOUNG: Nipple.

18 DONNA BLACK: Nipple. Okay, we didn't write that down. Do you  
19 call it the same as you call it on the little girl. So, Annie, has anybody, has there  
20 every been a time that somebody has touched you on one of those places that  
21 you didn't think somebody should touch? So, someone touched you on your  
22 pee-pee? Who touched you on your pee-pee?

23 ANNIE YOUNG: ...Ed, not that Eddie.

24 DONNA BLACK: Okay, a different Eddie. Do you know his name,  
25 his last name?

1 ANNIE YOUNG: Eddie Unley, Eddie Unley.

2 DONNA BLACK: Eddie what?

3 ANNIE YOUNG: Eddie Unley.

4 DONNA BLACK: Unley? Okay. And, now who is he? Who is  
5 Eddie?

6 ANNIE YOUNG: Well, he's one of mom's, he used, he used to be  
7 one of mom's friends. He has Kiki, one of his daughters and uh, a brother.

8 DONNA BLACK: Okay, so do they live with him?

9 ANNIE YOUNG: Yes. They live with him. And Kiki and his brother,  
10 and her brother, they have a little thing in the back yard that they go in...

11 DONNA BLACK: Uh huh.

12 ANNIE YOUNG: Or like a house, what they built (inaudible). I don't  
13 know what kind of games.

14 DONNA BLACK: Okay, so now this Eddie is not the same Eddie  
15 that lives with you, right?

16 ANNIE YOUNG: Right.

17 DONNA BLACK: Okay, so he lives somewhere else?

18 ANNIE YOUNG: Uh uh.

19 DONNA BLACK: Okay. So, now you told me that Eddie touched  
20 you on your pee-pee. Where, where did that happen? Where were you at when  
21 that happened?

22 ANNIE YOUNG: At his house.

23 DONNA BLACK: At his house? Okay. So, let's put Eddie's house  
24 over here. We know Eddie lives there. Who else lives there?

25 ANNIE YOUNG: Kiki.

1 DONNA BLACK: Kiki? And that's his daughter?

2 ANNIE YOUNG: Uh huh.

3 DONNA BLACK: Okay...

4 ANNIE YOUNG: I don't know her brother's name, I don't know his  
5 name. But sometimes I call him Michael.

6 DONNA BLACK: Michael. Does his brother live with him or does  
7 he...

8 ANNIE YOUNG: Lives with him.

9 DONNA BLACK: Lives with him. Okay, there's a brother, and you  
10 think his name's Michael. Okay, so tell me about the day this happened.

11 ANNIE YOUNG: Well, it happened a long, long time ago.

12 DONNA BLACK: Okay.

13 ANNIE YOUNG: when I stayed at his house.

14 DONNA BLACK: Okay, you spent the night at his house? Okay.

15 Ohm, do you remember if that was on a school night or...

16 ANNIE YOUNG: No, it wasn't a school night. And first he was  
17 gonna (inaudible)...,and he didn't. (Inaudible).

18 DONNA BLACK: Okay. And you watched..., you were gonna go to  
19 the store. Were you gonna go to the store with him or with your mom?

20 ANNIE YOUNG: Him. But he didn't want to.

21 DONNA BLACK: Okay. So how did you get to his house?

22 ANNIE YOUNG: My mom drove me over there.

23 DONNA BLACK: Your mom drove you over there, okay. So were  
24 you going over to spend the night or were you going over to play or something  
25 else?



1 ANNIE YOUNG: Spend the night.

2 DONNA BLACK: Spend the night?

3 ANNIE YOUNG: And play the game Mario.

4 DONNA BLACK: Play the game Mario. At you good at Mario? Do  
5 you like it?

6 ANNIE YOUNG: I can always win.

7 DONNA BLACK: Is that right? You do a good job huh? So Mom  
8 was taking you over to spend the night. Was Mom spending the night also?

9 ANNIE YOUNG: Uhm, no.

10 DONNA BLACK: No? So you were going over to spend the night?  
11 Okay, so when you, when Mom dropped you off over there, what happened  
12 then?

13 ANNIE YOUNG: I started to play Mario and then I watched Scooby  
14 Doo (inaudible)... he did that.

15 DONNA BLACK: Okay. And when you say "he did that", what do  
16 you mean?

17 ANNIE YOUNG: He touched me.

18 DONNA BLACK: He touched you know. So, where, what room of  
19 the house were you in when that happened?

20 ANNIE YOUNG: In the back bedroom.

21 DONNA BLACK: In the back bedroom. Okay, so if was his house,  
22 if this is Eddie' house, where's the door?

23 ANNIE YOUNG: I'll draw it.

24 DONNA BLACK: Okay. So you come in the door. When you come  
25 in the door, where would you have to go to get to the back bedroom? Over

1 here? Okay. So you, so when you first got there and you were playing Mario,  
2 you said you were playing Mario. Where were you at when you were playing  
3 Mario?

4 ANNIE YOUNG: Right there.

5 DONNA BLACK: Okay, what is that? What room is that that you  
6 were in?

7 ANNIE YOUNG: Living room.

8 DONNA BLACK: You were in the living room, okay. And so you  
9 played Mario. Did Eddie play Mario with you?

10 ANNIE YOUNG: Uh huh. (Inaudible).

11 DONNA BLACK: Okay, did anybody else play Mario with you?

12 ANNIE YOUNG: Uh huh.

13 DONNA BLACK: Who else played Mario with you?

14 ANNIE YOUNG: Kiki. (Inaudible).

15 DONNA BLACK: Okay, what games, and you were playing Mario.

16 What Mario is it?

17 ANNIE YOUNG: It's Mario (inaudible).

18 DONNA BLACK: Okay, and is it hard? Is it a hard one?

19 ANNIE YOUNG: For them, but not me.

20 DONNA BLACK: Oh, good. Okay, so you played Mario for awhile.

21 And then you said, what did you do after that? Okay. So you ended up going to  
22 this bedroom? Is that the bedroom you were gonna sleep in?

23 ANNIE YOUNG: Yeah.

24 DONNA BLACK: Whose room is that?

25 ANNIE YOUNG: Eddie's.

1 DONNA BLACK: That's Eddie's, okay.

2 ANNIE YOUNG: That's this Eddie.

3 DONNA BLACK: Okay, that's that Eddie, okay. So when you went  
4 to Eddie's room, how did you go to Eddie's room?

5 ANNIE YOUNG: I walked in.

6 DONNA BLACK: Did you walk there? Had he already told you  
7 when you got there that that's where you were gonna sleep?

8 ANNIE YOUNG: Yeah.

9 DONNA BLACK: Okay. So after you played Mario, then you went  
10 into Eddie's room. Okay, and then what happened?

11 ANNIE YOUNG: He touched that.

12 DONNA BLACK: He touched that, okay. Well, where were...

13 ANNIE YOUNG: Then he showed me this.

14 DONNA BLACK: Huh oh, I'm sorry, hon. Here...

15 ANNIE YOUNG: Then he showed me that.

16 DONNA BLACK: Okay. So when you were in the..., I'm gonna  
17 move this down a little bit so we can draw on it, okay? Uh, so how did that  
18 happen? Were you...

19 ANNIE YOUNG: Well, he, well...

20 DONNA BLACK: So did you go in, when you went into the  
21 bedroom, did you just go straight to bed, did you watch T.V. , did you play more  
22 video games?

23 ANNIE YOUNG: Well, I wanted to (inaudible.)

24 DONNA BLACK: Okay, and where was Eddie then?

25 ANNIE YOUNG: (inaudible)

1 DONNA BLACK: Okay, when you first went to the bedroom, did  
2 Eddie come to the bedroom with you or did he come later at some other time?

3 ANNIE YOUNG: Later.

4 DONNA BLACK: Some other time, okay. So you went back by  
5 yourself. And what happened? You got in the bed? Or something else? Okay,  
6 and so then what happened?

7 ANNIE YOUNG: Eddie come back there. He stomped.

8 DONNA BLACK: He stomped? Why did he stomp? Do you know?

9 ANNIE YOUNG: Well, he had shoes on. He was stomping and  
10 taking his shoes off.

11 DONNA BLACK: Okay. So he came to the bedroom and he  
12 stomped. It was loud? You could hear him coming through? Okay. And so  
13 when he got to the bedroom, did you say he took his shoes off? Okay, and you  
14 were already in the bed. So then what happened?

15 ANNIE YOUNG: And then that's when he showed me that.

16 DONNA BLACK: Okay. When you were laying the bed, did you  
17 have your clothes on or off or...

18 ANNIE YOUNG: On.

19 DONNA BLACK: You had your clothes on. Okay. And when  
20 touched you, you said he touched you there, when he touched you there, did you  
21 have your clothes on or off or something else?

22 ANNIE YOUNG: Well, he touched (inaudible).

23 DONNA BLACK: Okay. Did he touch under your panties or on top  
24 of your panties?

25 ANNIE YOUNG: Under.

1 DONNA BLACK: Under your panties, okay. Did your panties stay  
2 on you or did they ever come off?

3 ANNIE YOUNG: They stayed on.

4 DONNA BLACK: They stayed on, okay. Uhm, so did Eddie talk to  
5 you when he touched you there?

6 ANNIE YOUNG: Huh uh.

7 ANNIE YOUNG: Did you talk to Eddie? Did you say anything to  
8 Eddie?

9 ANNIE YOUNG: No. I asked him to stop.

10 DONNA BLACK: And then what happened?

11 ANNIE YOUNG: He didn't stop (inaudible).

12 DONNA BLACK: Okay. Uh, did he touch you on the outside of  
13 your pee-pee or the inside of your pee-pee?

14 ANNIE YOUNG: Inside.

15 DONNA BLACK: Inside. Okay, and what part of his body touched  
16 you on your pee-pee? Okay. What you're pointing to is weeny-bob. Okay. Did  
17 he touch your pee-pee with any other part of his body? What other part of his  
18 body touched you?

19 ANNIE YOUNG: His tongue.

20 DONNA BLACK: His tongue. Okay. Uh, so let me think about it a  
21 minute. What else happened? Can you think of anything else that happened?

22 ANNIE YOUNG: No.

23 DONNA BLACK: What made him stop?

24 ANNIE YOUNG: (inaudible).

25 DONNA BLACK: And did he tell you then when you told him you

1 were gonna tell your mom?

2 ANNIE YOUNG: He said not to (inaudible).

3 DONNA BLACK: Okay. So I'm a little bit confused. I'm gonna  
4 have to have you help me on something, okay? Uh, you said when he touched  
5 your pee-pee, he touched it with his weeny-bob, and he touched it with his  
6 mouth. Okay. Uh, or with his tongue. I'm sorry. You said tongue. But you told  
7 me you had your panties on.

8 ANNIE YOUNG: And then (inaudible).

9 DONNA BLACK: Okay, how far did he pull your panties down? Do  
10 you remember? To about your knees? Okay. Uh, I'm gonna draw, let's draw  
11 this. I want to say this is that back bedroom you were in, okay? So when you  
12 come into this room, where's the door? You can stand up there and show me.  
13 The door's over here? So you come into the room this way somewhere? Okay,  
14 and where were you at when this happened? Were you on the floor?

15 ANNIE YOUNG: The bed.

16 DONNA BLACK: The bed, okay. What's those? Are those the  
17 pillows?

18 ANNIE YOUNG: Yeah.

19 DONNA BLACK: Okay, so was your head uh, your head was up on  
20 the pillow. Okay. Uh, so when this happened, did Eddie have his clothes on or  
21 off?

22 ANNIE YOUNG: On.

23 DONNA BLACK: On, okay. Uh, so can you explain how that  
24 happened? When he touched your pee-pee with his weeny-bob and he had his  
25 clothes on?

1 ANNIE YOUNG: Well, and then he pulled his shorts down  
2 (inaudible).

3 DONNA BLACK: He left his shirt on. Do you remember what kind  
4 of shorts he had on? What kind of shorts did he have on?

5 ANNIE YOUNG: Red.

6 DONNA BLACK: Red shorts. Okay. And do you remember what  
7 kind of underwear he had on?

8 ANNIE YOUNG: White.

9 DONNA BLACK: White? Okay. Now did he take, did you say he  
10 took them off or just pulled them down or something else?

11 ANNIE YOUNG: Pulled them down.

12 DONNA BLACK: Okay. Do you remember how far he got them  
13 down? He had to take his pants down? (Inaudible). Uh, all right. When he was  
14 touching you with his weeny-bob, okay, you told me, did it go on the inside of  
15 your pee-pee or on the outside of your pee-pee?

16 ANNIE YOUNG: Outside.

17 DONNA BLACK: On the outside? Okay. When I asked you a  
18 minute ago, did you tell me that something went, did something go on the inside?

19 ANNIE YOUNG: With his hand.

20 DONNA BLACK: With his hand? Okay. So uh, so he touched you  
21 with his weeny, weeny-bob and with this hand? Okay. And when he touched

9 ANNIE YOUNG: He didn't quit.

10 DONNA BLACK: He didn't quit. Okay. So when did he quit?

11 ANNIE YOUNG: When I yelled.

12 DONNA BLACK: Okay. So did this happen one time? Just one...

13 ANNIE YOUNG: A long time ago.

14 DONNA BLACK: A long time ago? Okay. Did it ever happen  
again?

15 ANNIE YOUNG: Huh uh.

16 DONNA BLACK: No? Just one time, the one time you went to  
17 spend the night? Okay.

18 ANNIE YOUNG: I never spent the night there again.

19 DONNA BLACK: Okay, you never spent the night there again. Did  
20 you talk to anybody after that happened? Did you tell anybody about it? Okay,  
21 let's see if we can figure out, you said it was a long time ago. Do you remember,  
22 were you still in the first grade?

23 ANNIE YOUNG: (inaudible)

24 DONNA BLACK: Do you think you were in kindergarten when it

1 happened? Okay. Do you know was there, was there anybody else home when  
2 it happened? You said you'd been playing uh...

3 ANNIE YOUNG: And then they walked out the door to go  
4 somewhere.

5 DONNA BLACK: Okay. So you, when you were there, you were  
6 playing Mario, right? And at that time was Kiki there and Michel there when you  
7 were playing Nintendo? Okay, so after you got finished playing Nintendo...

8 ANNIE YOUNG: They left.

9 DONNA BLACK: Do you know where they went?

10 ANNIE YOUNG: Yeah.

11 DONNA BLACK: Where did they go?

12 ANNIE YOUNG: To one of their friends. I don't know their friend's  
13 name.

14 DONNA BLACK: Okay, did they ever come back?

15 ANNIE YOUNG: Yeah.

16 DONNA BLACK: Yeah. Did they come back before this  
17 happened?

18 ANNIE YOUNG: They came back after it happened.

19 DONNA BLACK: After it happened? Okay. So where did you end

7 DONNA BLACK: I know. I'm trying to get good questions.

8 ANNIE YOUNG: You only get three more.

9 DONNA BLACK: Okay, what grade did you tell me you were in  
10 when this happened?

11 ANNIE YOUNG: Kindergarten. And now we only have two more  
12 questions.

13 DONNA BLACK: Kindergarten.

14 ANNIE YOUNG: And now we only have two questions to ask.  
15 Right?

16 DONNA BLACK: Uhm, I hope. I hope. What did he look like?

17 ANNIE YOUNG: He had brown hair.

18 DONNA BLACK: Okay, okay. Yeah, I want you to describe to me  
19 what Ed looked like. Okay? Tell me everything you know about him.

3 DONNA BLACK: Uh, let me walk over there for just a second.

4 ANNIE YOUNG: No, I want to go with you.

5 DONNA BLACK: Uh, you want to go? Let me ask them. Anything  
6 else, guys? Okay. I think we're done. Is that okay? Uh, any questions for me?

7 ANNIE YOUNG: Uh, nope.

8 DONNA BLACK: Okay. Good. You know what a kid asked me last  
9 week?

10 ANNIE YOUNG: What?

11 DONNA BLACK: When I asked him if he had any questions for  
12 me? He said, "Yeah, will you go to my birthday party at Chuck E. Cheese's?"
