
**MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS**

6. Nunley brings this motion in good faith and believes that he is entitled to the relief sought.


**WHEREFORE**, Petitioner prays this Honorable Court will grant this motion and all other relief the Court may deem just and proper within the premises.
